



## Worldwide Limited Warranty

Effective October 2001

Starting Serial Number By Model Available Upon Request

OnePress Co. warrants to the original purchaser that all new OnePress™ brand flatwork ironers ("Equipment") and all new replacement parts ("Parts") to be free from defects in material and workmanship under normal use and service. The normal use of the Equipment and Parts is in commercial and industrial laundries. The term of the obligation of OnePress Co. under this limited warranty shall be limited as follows:

- (a) For a period of three (3) years from the date of installation of the Equipment, but no later than three-and-one-half (3-1/2) years from the date of the manufacture of the Equipment providing installation is completed by an authorized OnePress™ Distributor, if not, then two (2) years from the date of installation of the Equipment, but no later than two-and-one-half (2-1/2) years from the date of the manufacture of the Equipment applies.
- (b) For a period of five (5) years from the date of installation for the main frame and all rolls, but no later than five-and-one-half (5-1/2) years from the date of manufacture thereof; and
- (c) For all Parts, the remaining term of the limited warranty of the Equipment to which the Parts are incorporated or one (1) year from the date of sale of the Parts, whichever time period is greater.
- (d) Specifically excluded are roll covers, padding, feed/return ribbons, gaskets, seals and belts.

The obligation of OnePress Co. under this warranty is further limited to the repair or replacement of the Equipment or Parts, free of charge, FOB a designated facility of OnePress™. OnePress Co. shall have the sole discretion to determine whether any Equipment and Parts presented to it under this limited warranty is defective and whether the same shall be repaired or replaced. All transportation charges and duties shall be borne by the purchaser. This warranty does not include any labor expenses to diagnose, adjust, service, remove, install, replace or any other labor expense for Equipment or Parts.

This limited warranty shall be the limit of the liability of OnePress Co. for any breach of warranty. Purchaser must notify OnePress Co. by registered mail or certified mail, return receipt requested, of a breach of warranty within thirty (30) days after the discovery thereof, but no later than the warranty period, time being of the essence. No allowance shall be granted for any alterations made to the Equipment or Parts by the purchaser without prior, written consent of the President of OnePress Co. OnePress Co. shall have the discretion to require that the purchaser return to OnePress Co. any and all defective Equipment and Parts, or portions thereof. However, no Equipment or Parts shall be returned to OnePress Co. for repair or replacement without the prior written authorization of OnePress Co. The determination by OnePress Co. not to require the return to it of defective Equipment or Parts shall not be deemed to constitute a waiver of other terms of this limited warranty or of its right to enforce all of the terms of this limited warranty thereafter.

OnePress Co. does not warrant that the Equipment or Parts shall meet the requirements of any safety code of any state, municipality or other jurisdiction other than the safety agency approvals as stated on the machine. Purchaser assumes all risk and liability whatsoever resulting from the use of the Equipment and Parts, whether used singly or in combination with other machines or apparatus.

This limited warranty shall not apply to persons or parties other than the original purchaser of the Equipment or Parts. This warranty shall not apply to any Equipment or Parts, which have been altered without the written consent of the President of OnePress Co., or altered in any way so as in the judgment of OnePress Co. to affect adversely the stability or reliability of the Equipment or Parts. This limited warranty shall not apply to Equipment or Parts in which parts from a manufacturer other than OnePress Co. have been incorporated or equipment or parts which have not been purchased from OnePress Co. Further, this warranty shall not apply to Equipment or Parts that have been subjected to misuse, negligence, have not been installed, maintained and operated in accordance with the printed instructions provided by OnePress Co. This warranty shall not apply to Equipment or Parts that have not been utilized for their normal use or have been operated under conditions more severe than, or otherwise exceeding, those set forth in the specifications for the Equipment or Parts. Damage caused by weather variations, temperatures, water or chemicals are not covered by this warranty. OnePress Co. reserves the right to change components, assemblies, design or construction of its Equipment without notice and without obligation to update or modify any previously supplied OnePress™ Equipment or Parts.

THIS WARRANTY IS EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES EXPRESS OR IMPLIED, INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR USE AND ALL OTHER OBLIGATIONS OR LIABILITIES ON THE PART OF ONEPRESS CO. ONEPRESS CO. NEITHER ASSUMES NOR AUTHORIZES ANY OTHER PERSON TO ASSUME FOR ONEPRESS CO. ANY OTHER LIABILITY IN CONNECTION WITH THE SALE OF THE EQUIPMENT AND PARTS. THIS LIMITED WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES AND PURCHASER HEREBY WAIVES ALL OTHER REMEDIES, WARRANTIES, GUARANTEES OR LIABILITIES, EXPRESS OR IMPLIED, ARISING BY LAW OR OTHERWISE (INCLUDING WITHOUT LIMITATION ANY OBLIGATIONS OF ONEPRESS CO. WITH RESPECT TO FITNESS, MERCHANTABILITY, INCIDENTAL DAMAGES AND CONSEQUENTIAL DAMAGES) OR WHETHER OR NOT OCCASIONED BY THE NEGLIGENCE OF ONEPRESS CO. THIS WARRANTY SHALL NOT BE EXTENDED, ALTERED OR VARIED EXCEPT UPON THE PRIOR WRITTEN INSTRUMENT SIGNED BY THE PRESIDENT OF ONEPRESS CO.
